Chairman & Chief Executive Officer, Fairfax Holdings Limited



- Fairfax Holdings Limited, a property and casualty insurance and reinsurance company, was founded by Prem Watsa in 1985. Prem led the company's global expansion and evolution, establishing Fairfax as a worldwide leader, operating in more than 100 countries.
- Mr. Watsa is a Recipient of the Order of Canada and the Padma Shri Award, one of the highest awards in India. He is active on a number of Advisory Boards and is a member of the Sick Children's Hospital Foundation and Chairman of their Investment Committee.
