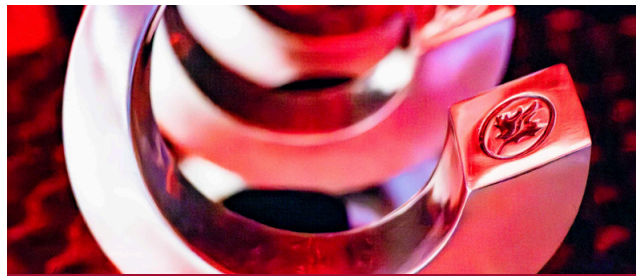

About the **Selection Process**

Inductees to the Order of the Canadian Business Hall of Fame (CBHF) are selected through a **nomination process** and appointed by the CBHF Selection Committee. The Committee's invaluable work identifies **individuals who best embody the values of the CBHF and JA Canada**, joining the ranks of Canada's most accomplished leaders as Companions of the Order of the Canadian Business Hall of Fame.

Our **Selection Committee Partner**

Korn Ferry exclusively manages the CBHF selection process. In addition to receiving nominations, Korn Ferry is responsible for managing the **overall search by identifying and shortlisting potential nominees** according to the key criteria established by the CBHF Selection Committee which includes extensive research, speaking with senior business leaders, and leveraging their extensive leadership and Board network across Canada.

Key Criteria when Selecting Inductees

Vision & Leadership

Candidates have demonstrated exceptional vision and leadership, elevating one or more business organizations to new heights. Widely recognized and applauded, their initiatives and legacy stand out.

National Impact

Nominees have had an impact on the Canadian economy through verifiable financial success, job creation, expansion and innovation. Challenges encountered along the way have been overcome through vision and determination.

Civic Leadership

Honourees have utilized their influence and energy to further Canadian social and economic wellbeing, as demonstrated through leadership in philanthropy or in community-based initiatives.

Role Model

Inductees are widely respected, considered exemplary role models for young Canadians, and recognized for their character, integrity and contributions to cultivating talent.

Eligibility

Awardees are Canadian citizens. They must have demonstrated national business leadership and attained senior status in the enterprise and business sector in which they gained prominence.
